#### 1.SCOPE

#### 2.PURCHASE, INVENTORY & REPORTING REQUIREMENTS

Pro PERKS sales will be reviewed with Contractor on a quarterly basis to verify volume commitment is met and **if annual volume requirement is met, the bonus Pro PERKS points will be fulfilled in Q1 of the following calendar year**.

Bonus percentages of Pro PERKS points are not cumulative and the maximum points a contractor can earn is the higher of the percentages earned. For example, a contractor that normally receives 3% through the standard Pro PERKS and qualifies for 4% in the Pro PERKS RNC Potable Program would receive a total of 4% on eligible categories, not 7%.
